New Center Council has partnered with Manpower Metro Detroit, located in the Fisher Building, to offer discounts on staffing services to our members.

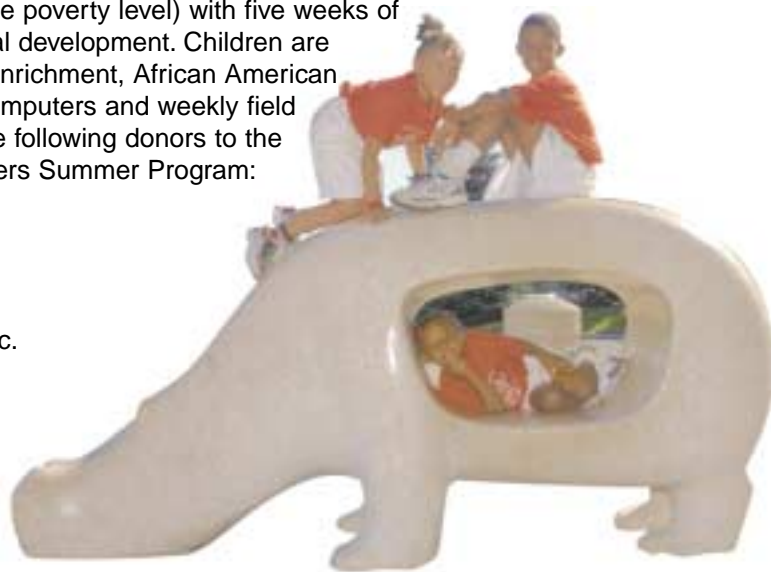
